Mecklenburg County's Solid Waste Division will hold its next "Spring Shredding Saturdays" event on March 17 at Compost Central, 140 Valleydale Road, Charlotte. A shredding truck will be there from 9 a.m. to noon (or until the truck reaches capacity).

County residents will be able to drop off their documents free of charge. There is a limit of three banker's boxes per car. Metal binders, paper clips and plastic bags are prohibited. The event is only open to residential customers.

Spring Shredding Saturdays will continue until June 2018, with events occurring the third Saturday of each month. Future dates include April 21, May 19 and June 16.

field when Park and Recreation kicks off its annual Recreation Employment Corps Mentor/Mentee program with an orientation session on Wednesday, March 14. The program will begin at 6 p.m. at the Bette Rae Thomas Recreation Center, 2921 Tuckaseegee Road.

Each year, students go through an application and interview process, and a select few are chosen and paired with a Park and Recreation staff member at a nature center the Mecklenburg County Aquatic Center or a recreation center. Students are able to work for 10 hours a week for 40 weeks.

During the program, mentees learn positive work skills and habits which will serve them throughout life. Many even get a chance to help with the planning process of some of Park and Recreation's programs and events.
