Right to Access Public Records



Last week, I co-sponsored [**SB911, Constitutional Amendment/Right to Access Public Records**](#). The public's right to access state lawmakers' records was eliminated as part of the 2023-24 State Budget and lawmakers were authorized to keep secret, sell or destroy any records. I opposed that change. This constitutional amendment would allow voters to decide who gets to have access to those records. **Communications regarding decisions and legislation that affect all North Carolinians should be made accessible to all North Carolinians, and this amendment would make that access a right.** Unfortunately, we do not expect the majority party to allow the proposed Constitutional Amendment to be on the ballot.

Updates on Noteworthy Votes



Below are the noteworthy bills I voted on over the past two weeks. You can find a complete list of bills I voted on [here](#).

Key bills on which I voted YES:

- **SB124, Predatory Roofing/Insurance Rebate Reform.** This bill protects homeowners from predatory practices involving roof repair by requiring all roof replacement or repair contracts to have a five-day cancellation period in the event that an insurance company denies a repair claim, and by placing a cap on insurance referral fees paid to non-licensed individuals.
- **HB223, OSHR/Various SHRA Changes.** While the Senate majority tabled my amendment to improve this bill by increasing teacher and state employee salaries (the true root of the problem), this bill will help address the vacancies in public schools and state government jobs by making information regarding employment opportunities in state departments more accessible, and the hiring process more fluid by eliminating the 21-day listing period requirement.
- **HB495, Revise Money Laundering/Retail Crime.** Addresses retail theft by permitting the aggregation of multiple convictions of financial crimes for sentencing, as well as creating new offenses for intentionally attempting to purchase goods with false price tags. Provides jurisdiction to the court of each county where one of the financial crimes occurred.

Key bills on which I voted NO:

- **SB565, Amend Expunction.** When the bill left the Senate, it carried with it recommendations made by district attorneys and clerks to address the challenges presented by 2020's **Second Chance Act**, which allows the automated expunction of "not guilty" and "dismissed" criminal charges. This bill has changed a lot since its first edition (when I actually co-sponsored and supported it). The name even changed. As it left the House and returned to the Senate, the new version instead repeals automatic expungement all together. **That is a significant rollback of the Second Chance Act, so I voted no** on the motion to concur this week, and I won't support the current version. Update on HB237: Mask Ban and Campaign Finance Changes



When **HB237, Various Criminal and Election Law Changes**, was first introduced in the Senate, it was not shared with Democratic Senators until it was on the Senate floor, and it was introduced using a method that cut off the option to offer amendments. In response, [my Senate Democratic colleagues and I walked out during the vote last week in protest](#).

After passage in the Senate of the original version of HB237, there was loud outcry from the public in opposition and the House promised they would fix it before they passed it. But the House amendments fell short and did not address immunocompromised individuals, other high-risk individuals and their families, or other valid reasons for wearing a mask. The bill still empowers anti-mask activists to force people to remove their masks, which will create havoc and risk. The provisions designed to silence protestors and alter campaign finance laws are also unacceptable.

There are many unanswered questions about how its language will be interpreted, including important details necessary to ensure we don't make careful people into criminals and don't empower anti-maskers to harass immunocompromised and other vulnerable people by forcing them to remove their masks in public. It will also lead to a [massive influx of dark money into state races](#).

The House of Representatives voted on the bill this week; it passed. It will now go to the Governor's desk to be signed or vetoed. **If Governor Cooper vetoes this law, I will vote to uphold his veto.** Learn more [here](#).

Senate Judiciary Committee Updates



The following noteworthy bills were discussed in the Senate Judiciary Committee over the past two weeks:

- **SB802, C-PACE Program.** Establishes the commercial property assessed capital expenditure program ("C-PACE Program") to be administered by the Economic Development Partnership of North Carolina ("EDPNC") under the supervision of the Department of Commerce. Under the C-PACE Program, owners of qualifying commercial property could apply to EDPNC to be approved for long-term financing provided by private lenders to pay for property improvements that would include **energy efficiency, water conservation, renewable energy, and resilience measures**. I am a co-sponsor of this bill.
- **HB98, Right to Try Individualized Treatments.** This week, the committee approved a PCS/amendment that removed all language in the original bill and replaced it language from **SB871**, which would allow eligible patients with life-threatening or severely debilitating illnesses the right to try individualized investigational drugs, biological products, and devices. I'm inclined to support the bill, but it will go through some amendments before it's ready.
- **HB199, DMV Proposed Legislative Changes.** Authorizes and studies issuance of a digital version of a drivers license that can be displayed on a mobile device as a supplement to a traditional drivers license. Requires ignition interlock as a condition for restoration of a drivers license when revocation was based on a conviction of death by motor vehicle when impaired driving is an element of the offense. Updates statutory odometer disclosure, all headlamps modified or installed on a motor vehicle, and statutes related to commercial drivers licensing to conform to federal standards. Increases the penalties for littering. Modernizes a variety of other registration and transaction-based statutes involving vehicles to account for changing technologies.
- **HB250, ME/IDS/Driving Privileges/Xylazine Changes.** The problematic changes to this bill discussed last week that would limit the public's access to autopsy reports, were dropped from the version of this bill that passed through the committee. Instead, the bill includes training regarding sudden unexpected death in epilepsy for medical examiners, clarifies the authority of medical examiners and district attorneys in regard to decedents whose deaths are under criminal investigation, provides the eligibility requirements for granting a limited driving privilege to a person whose drivers license is revoked because of a conviction for an offense of impaired driving, and creates the new offense of death by distribution of xylazine. Compromises were also made on the changes in the membership of the Indigent Defense Services Commission.
- **HB495, Revise Money Laundering/Retail Crime.** See "*Updates on Noteworthy Votes.*"
- **HB563, Hemp-Derived Consumables/Con Sub Changes.** Prohibit the sale to and purchase of hemp and hemp-derived products by people under 21 years old. Requires sellers to have a license to sell and for manufacturers to test products before distribution. Adds child-resistant and labeling requirements to packaging for these products, among other regulations. Add kratom, xylazine, and tianeptine to North Carolina's list of controlled substances. Senate Redistricting and Elections Committee Updates



The following noteworthy bills were discussed in the Senate Redistricting and Elections Committee over the past two weeks:

- **SB912, Elections Changes for Watauga Education & County Boards.** Redraws electoral districts for the Watauga County Board of Education to eliminate all at-large members and instead have districts that align with the County Board of Commissioners' districts. Prohibits the Watauga County Board of Commissioners from changing its method of election or electoral districts before the return of the next federal decennial census. This change that will give a partisan advantage to Republicans and was done without the input of the local elected Board. Watauga County voters have let me know that they oppose this bill, and I raised issues during the committee meeting. But it's a local bill, so the NCGA will defer to that county's legislators.

Senate Education Committee Updates



The following noteworthy bills were discussed in the Senate Education Committee over the past two weeks:

- **HB97, Various Education Changes.** Requires the State Board of Community Colleges to create a program to provide mathematics, reading, and English remediation to high school seniors. Allows students to receive the remediation during the summer prior to their senior year. Increases the number of classroom hours required for massage therapy licensure from 500 to 650. Changes the requirements of proprietary schools regarding student protections and tuition to be in line with federal requirements, and increases the catastrophic loss amount of the Student Protection Fund from \$1,000,000 to \$1,500,000 and the cap amount from \$1,500,000 to \$2,000,000. This fund is used to compensate students enrolled in a proprietary school when it ceases operation.
- **HB207, Discipline Changes.** Gives more due process rights to students who receive suspensions. Requires principals to accept a detailed, written eyewitness account of an incident that could result in a short-term or long-term suspension within 24 hours of the incident. Requires the principal or the principal's designee to provide the student with detailed, written documentation of the specific section of the public school unit's Code of Student Conduct that the student's conduct violated and how the conduct violated it. Revises short-term suspension procedures to allow for appeals and expungements.

ARTS Day Recap



A Better Response: Policies to Improve America's Mental Health Crisis System



[Inseparable](#) released a new report, *A Better Response: Improving America's Mental Health Crisis System*, which analyzes mental health crisis response across the country and provides policy recommendations to improve it. Part of this study included State Snapshots targeted at each individual state's needs and policies. This snapshot found that only 81% of Suicide & Crisis Lifeline calls routed to the state are answered by an in-state call center. In addition to identifying crisis response needs, the report also encourages specific policy measures to improve the system, such as system financing and accountability measures. In particular, North Carolina could benefit from a 988 phone surcharge, like 911 surcharges on phone bills, and state insurance code requirements that qualified mobile response and crisis stabilization services must be covered in the same manner as physical health emergency services. The report also found the state in need of a complete overhaul in regard to accountability. Read the full report [here](#).

UNC Researchers Launch Study of Thyroid Cancer Incidence in North Carolina



The North Carolina General Assembly has funded a new investigation by UNC Lineberger Comprehensive Cancer Center that will **study the relationship between thyroid cancer cases statewide and specific environmental exposures**. This study will focus on all new thyroid cancer cases diagnosed in North Carolina from 1995 to 2021. Members of the research team will include researchers from UNC Lineberger, UNC Institute for the Environment, UNC Gillings, Duke University, North Carolina State University, the National Cancer Institute, and the North Carolina Department of Health and Human Services. While the study will examine cases statewide, there will be a **particular focus on Iredell County, as reports of thyroid cancer cases around Lake Norman have been noticeably higher there than anywhere else in the state**. Last week, I stood with the gun violence prevention movement to commemorate National Gun Violence Awareness Day at the General Assembly. Firearms are the leading cause of death for children and teens across America, and every day, more than 120 Americans are killed with guns. My colleagues at the General Assembly and I wore orange to show our commitment to advocate for common sense gun reform.

I attended the [North Carolina Forestry Association's](#) Legislative Reception. They shared their legislative agenda to preserve our great natural resources, including support for reinstatement of the land conservation tax credit.



I attended the **Mecklenburg County Advocacy Reception**, where the county shared its **need for state funding to keep childcare centers open** and to help low-income families pay for childcare. It's a necessary investment needed to enable parents to work and children to be safe. They also shared the need for **more robust public school funding**, support for **transportation initiatives**, and other Mecklenburg priorities.

I also attended the dinner hosted by the **NC Association of County Commissioners**. Sen. Phil Berger and Speaker Tim Moore were the guest speakers. Unfortunately, they did not indicate support for addressing the needs that the counties have, like higher teacher pay and childcare stabilization funding.



I met with constituents Virginia (who also works with Planned Parenthood) and Sarah on **Equality NC's** Advocacy Day. We discussed the rise of anti-LGBT legislation in North Carolina, including the ban on gender-affirming care for transgender youth (**HB808**), the prohibition of trans women and girls from participating in public sports teams (**HB574**), and the ban on early education about LGBT identities in public schools (**SB49**).

NC SUMMER Nutrition Programs

More than 900,000 North Carolina students rely on the nutritious meals and snacks served during the school year through the School Breakfast, School Lunch and Afterschool Snack Programs. When school is out, those low-income children lose access to meals. Summer Meals Programs provide nutritious meals at no cost for children and adolescents ages 18 and younger to help close that gap.

Sun Bucks Update



The USDA has launched a permanent program to provide food assistance to children and families during the summer. SUN Bucks will provide grocery-buying benefits to qualifying families with school-aged children during the summer months when schools are on summer break. SUN Bucks will be issued to EBT cards that families can use to purchase nutritious food. Beginning in summer 2024, families will receive \$120 per eligible child for the summer period. Some families will have to apply for the program, but many students will automatically qualify. Children will automatically qualify if they already participate in any of the following programs:

- Free or Reduced-Price (FRP) meals at school because they have an approved FRP application at school, or
- Food and Nutrition Services (FNS, food stamps), or
- Work First (Temporary Assistance for Needy Families (TANF), cash assistance), or
- Medicaid with household income below 185% of the federal poverty level, or
- Foster care.

Families will be able to use their EBT cards to buy food at grocery stores, farmers' markets, and [some online retailers](#). Saturday Hours at Select DMV Offices This Summer



The North Carolina Department of Motor Vehicles has announced it is offering summer Saturday hours at 16 offices. These walk-in services will be provided on Saturdays from **June 8 through August 24 from 8:00 AM - 12:00 PM**. Services available during the Saturday hours include driver's licenses or ID cards, renewals or duplicate orders, address changes, REAL ID issuances, and road tests for customers who have already completed the knowledge and written tests. Among these 16 offices are the Charlotte North (**9711 David Taylor Dr., Charlotte, NC 28262**), Charlotte South (**201 W. Arrowood Rd., Suite H, Charlotte, NC 28273**), and Huntersville (**12101 Mount Holly-Huntersville Rd., Huntersville, NC 28078**) DMV locations.

Recently, DMV has faced a print production backlog as the result of the new photo ID requirement for voting, the impending requirement of a REAL ID to fly domestically beginning in May 2025, and a production glitch by the private contractor. 
